## Terms and Conditions:

**Have the kitten examined by a certified Veterinarian within 5 Days.** The kitten, to the best of the Seller's knowledge, is in good health at time of sale. Failure to have the Kitten examined by a vet, within 5 days after taking delivery, will void the health guarantee. The breeder guarantees the kitten until one year of age against all life threatening congenital or hereditary defects. If this occurs and with a veterinarians verification, a replacement kitten of equal value will be provided as soon as nature permits, hopefully within 6 months. The original kitten must be returned (at owners expense), to Seller before a new kitten can be delivered. The purchaser is responsible for any shipping fees for the replacement kitten. In the event of death, a licensed veterinarian must perform an autopsy to determine the exact cause of death at owners' expense with the report sent to seller's attending veterinarian for review. This guarantee does not cover: Hypoglycemia, coccidiosis, giardia, hernias, weight, breeding ability, or any other health standards for a kitten. Failure to provide your kitten with veterinary care will void this guarantee. At no time will Seller be responsible for your Veterinary Costs. We encourage you to purchase pet medical insurance such as Trupanion or another insurance.

**Breeding Rights**. This kitten / Cat is not sold with breeding rights. If Buyer wishes to obtain breeding rights, a different sales agreement must be made with the additional fee associated with breading rights. The Kitten is sold as pet quality.

**Spay/Neuter.** Your vet will be able to offer advice on when to spay or neuter your kitten, however it is typically recommend that this be done around five to six months of age.

**Provide proper vaccinations for the kitten on a schedule determined to be proper by a certified veterinarian.** It is essential that your kitten be vaccinated and checked for parasites (internal and external) on a schedule prescribed by a certified veterinarian. You will be provided a medical record for the kitten along with other paperwork. Be sure to review the medical record with your veterinarian and get a recommendation for follow-up. **Never have any of the kitten's paws de-clawed.** Declawing is a horribly painful and abusive surgical procedure that is without benefit to the cat. It is illegal in most countries. Declawing is an irreversible surgical procedure.

**All Sales are final.** Except as noted above, all kitten / cat sales are final. No refunds will be provided and in the event of an issue as noted above the kitten /cat will be replaced the kitten of equal value as soon as nature permits, hopefully within 6 months. Replacement is dependent upon the return of the kitten / cat.
